Database Implementation Status

South Dakota has had a bottom-up statewide voter registration system in place since 2002, in which forms processed at the county level are uploaded daily to the statewide database.² This database was built in-house.³

Entering Voter Registration Information

Who inputs voter registration information? County auditors generally review and enter information from voter registration forms in their jurisdictions into the appropriate county database; this information is uploaded nightly to the statewide database.⁴

What happens to voter registration forms submitted at state registration agencies? Forms received by the Department of Public Safety (“DPS”) or another voter registration agency are sent weekly to the appropriate county auditor for review and entry; forms completed at the DPS will be transmitted electronically.⁵

How are most forms submitted? South Dakota reported that in 2004, 25% of forms were submitted by mail, 63% were submitted in person to election officials, 4% were submitted at the DPS, and 8% were submitted at another voter registration agency.⁶

Voter Registration Form

The relevant portions of the voter registration form are included at the end of this section.

Processing of Forms Without Identifying Numbers

How will the state treat an application with an affirmative indication that the applicant has no valid identifying number? South Dakota’s form does not clearly state how an applicant should indicate that she has no valid identifying number. An applicant who has neither a valid driver’s license number nor a SSN must appear in person at the county auditor’s office to sign a statement under oath to that effect.⁷

How will the state treat an application without an identifying number and without an affirmative indication that the applicant has no such number? If uncorrected (see below), the application will be rejected.⁸

How will the state treat an application listing an identifying number that is either incomplete or illegible? If uncorrected (see below), the application will be rejected.⁹

Matching Against Motor Vehicle and Social Security Records

What fields from the voter registration form will the state seek to match to motor vehicle or Social Security records? Identifying number, last name, first name (including variants), and date of birth.¹⁰

How precise is the match standard? South Dakota requires an exact match.

How much human intervention is involved in determining whether information is matched? For applicants submitting out-of-state driver's license numbers, the state will attempt to match information based on the system implemented by the appropriate state. For forms with South Dakota driver's license numbers, the initial screening process is fully automated, but the forms with information that cannot be matched automatically are then checked manually.

Description of matching process: Information from voter registration forms uploaded to the state database will be automatically checked against the database of the DPS, the Unified Judicial System, and the Department of Health, and the system will return a code denoting the presence or absence of a match.¹¹ This match process generally takes place within 24 hours. State elections officials will also phone out-of-state DMVs directly, to attempt to match the information on forms with out-of-state driver's license numbers.

After an initial automated match is attempted, the records of voters whose information does not match the identifying-number databases, or whose information matches the felony conviction or deceased databases, will be referred by e-mail to the county auditor, who will manually review the voter's application and information collected from the appropriate state agency.

Information on forms listing SSN digits will be automatically checked against the SSA database through the standard AAMVA process: the DPS will automatically submit the SSN digits, last name, first name, month of birth, and year of birth to the SSA, and the system will return a code indicating whether the record was successfully matched or not.¹²

What are the consequences if the state cannot find a match? If uncorrected (see below), the application will be rejected.¹³

Notice and Opportunity to Resolve Errors

Does the applicant have the opportunity to correct a missing or incomplete identifying number, without submitting a new form? Yes. The applicant may correct missing or incomplete information at any point before the voter registration deadline.¹⁴

Does the applicant have the opportunity to resolve a failed match, without submitting a new form? Yes. The applicant may submit information to resolve a failed match at any point before the voter registration deadline; if the voter supplied complete and correct

information on her original application, a failed match may be corrected at any point before Election Day.¹⁵

If information on an otherwise timely application is corrected after the voter registration deadline, is the correction timely? No – except that if the voter supplied complete and correct information on her original application, the registration will be timely as of the date the original application was submitted.¹⁶

Description of notice and correction process: The county auditor will attempt to notify by mail an applicant whose identifying number is missing, incomplete, illegible, or unverified.¹⁷ The applicant may attempt to resolve the error at any point before the voter registration deadline, by phone, mail, or in person; if the error is not due to the information on the applicant’s timely form, she may attempt to resolve the error at any point before Election Day. If the identifying number cannot be verified, the application will be rejected.

Identification Requirements at the Polls

Who must provide identification at the polls? Every voter must present identification at the polls.¹⁸

What forms of identification are accepted? A South Dakota driver’s license or non-driver identification card; a passport or other photo ID issued by the federal government; a tribal photo ID card; a photo ID card issued by a South Dakota high school or university; or a personal identification affidavit listing the voter’s current residential address and declaring that the voter is the person listed on the registration list.¹⁹

What are the consequences of failing to show identification? If identity cannot be proven to the satisfaction of the poll worker through the presented photo identification or affidavit, or “other forms of identification, personal knowledge, and an explanation” from the voter, the voter may vote by provisional ballot.²⁰ This ballot will be counted unless there is no evidence that a voter registration form showing a valid residential address in the appropriate precinct had been completed by the voter and returned to an official voter registration site before the voter registration deadline.²¹

Statutes and Regulations

S.D. CODIFIED LAWS ch. 12-4 generally concerns registration. S.D. CODIFIED LAWS § 12-4-37 directs the Secretary of State to establish and maintain a single statewide voter registration system. S.D. ADMIN. R. 5:02:03:12 *et seq.* comprise the applicable regulations.
